PSC General Meeting Minutes, March 19/2025, Kathrine Threefoot, Secretary

- 1) About 28 people enjoyed Happy Hour at RVCC before the meeting. At least 12 people joined by Zoom.
- 2) Meeting Called to Order at 8:05 by Commodore Angela Rowland.
 - a) Angela introduced the speaker Rick Rodriguez to talk about going From Sailing to Life Raft in less than 20 minutes!
 - Rick Rodriguez and crew were 1,200 miles from the Marquesas in the pacific when their yacht sank within minutes." Yachting World June 2023
 - c) Yacht Captain and Marine Surveyor tells the story of an abandon ship in the middle of the South Pacific after a large whale struck his Kelly Peterson 44. Expect to learn what was done right, what could have been done better, and what almost went horribly wrong. Is there a hot spot for South Pacific whale strikes that you should be aware of?
 - d) Bought second boat: 1976 Kelly Peterson 44. Sailed along east coast, then to Florida, Bahamas, Panama, en route to South Pacific. COVID restrictions caused them to stay a year in Panama. Finally went through Panama Canal and on to Galapagos. Encountered the whale after the Galapagos, with 1300 miles to go. Whale was the size of the boat or bigger and was bleeding from its impact with the stern of the boat. Bilge alarms went off and crew began to pack up to abandon ship.
 - e) Boat had 2 EPIRBs. Made MayDay call. Deployed the life raft. Put the dinghy in the water. Used a snorkel to inspect hull damage from outside the boat. Boat is made as a split hull because of hull shape. This creates a week point. Life raft painter line still attached when boat sank rapidly. Important to have knife available to cut line.
 - f) From life raft and dinghy, activated SOS on Iridium Go. Sent messages to various people. Battery was low as it had just been set to recharge. Shut down to conserve battery.
 - g) Food and water inventory indicated 25 days of food 8 days of food. Had a rain catcher, but recommends having a handheld water maker. Time to drift to Marquesas estimated at 38 days. 20 boats responded to distress call. Nearest boat was about 8 hours away for night rescue. Established night watch schedule to repeat MayDay call and sight for rescuing boats.
 - h) Key learnings.
 - a. Stabilize the boat before deploying life raft.
 - b. Preview scenarios in advance; e.g. painter line tied to boat. Crew not equally experienced or briefed on contingencies.
 - c. Put passports in primary ditch bag.
 - d. Keep Iridium Go battery at high charge level. Have portable solar charger.
 - e. Be clear on PFD policy.
 - f. Only one line connecting Life raft and dinghy. Should have secondary line. Also secondary radio.
 - g. Ditch bag essentials: EPIRB, SAT phone, Charged batteries, solar charging power bank, handheld VHF, multiple ditch bags or Kits in Dry bags, water maker of solar stills, Spear gun
 - h. Prep the dinghy: Having both life raft and Dinghy was extremely beneficial.
 - i. Life raft considerations: Square may be better than round, double chamber, check capacity, insulated floors, hydrostatic release, ventilation, sea sickness, storage space for supplies,
 - j. Understand bilge pump design. They are not intended to remove water fast enough to prevent sinking.

BoatUS Consumer Alert: Be Wary of Any Letter Arriving by U.S. Mail Offering U.S. Coast Guard Documentation Renewal

Official-looking vessel documentation renewal notices can lead to confusion and higher costs

SPRINGFIELD, Va., Jan. 27, 2025 – Boat Owners Association of The United States (<u>BoatUS</u>) is advising boaters with vessels that have a <u>U.S. Coast Guard Certificate of Documentation</u> to be wary of any letter arriving by U.S. mail offering renewal.

BoatUS advises that while the Coast Guard does send official annual renewal notices by U.S. mail, other notices being received by BoatUS members are not from the Coast Guard but rather third-party companies whose name or return addresses may appear similar to that of the official U.S. Coast Guard National Vessel Documentation Center (NVDC).

BoatUS members have complained that these letters direct them to websites that may be mistaken for the actual Coast Guard NVDC located in Falling Waters, West Virginia, and appear to show a significant increase in the annual fee to renew Coast Guard documentation.



A 2017 Coast Guard issued bulletin says in part:

"The NVDC is aware that there are commercial entities that offer to manage the certification/renewal process on behalf of vessel owners for a fee. The Coast Guard does not endorse any of these companies, and the companies do not operate on behalf of the Coast Guard in any way. Any fees charged or agreements offered by such companies are in no way associated with the NVDC certification process. In addition, these companies are not authorized to issue any form of documentation, including travel letters and/or permits that authorize operation of ANY vessel. Customer complaints can be made through the Federal Trade Commission's (FTC) website at <u>https://www.ftc.gov/</u>."

While third-party companies may legitimately provide services to assist with vessel documentation renewals, the Coast Guard's own renewal process is simple for most

vessels, and the price ranges from \$26 for one year up to \$130 for a 5-year expiration, which is often much lower than what third-party services may charge.

To renew, go to the Coast Guard National Documentation Center website at <u>https://www.uscg.mil/nvdc</u> and click on "instructions and forms," then "Certificate of Documentation Application for Renewal."

To be documented, a vessel must measure at least 5 net tons and, with the exception of certain oil-spill response vessels, owned by a U.S. citizen. Boats about 27 feet in length or longer generally meet the weight requirement.

Why do boat owners choose to federally document vessels with the U.S. Coast Guard versus the more common practice of state registration? The boat was purchased with a bank loan and the lender required it, or the boat has plans to travel beyond U.S. waters. A Certificate of Documentation is internationally recognized and makes it easier for American vessels to enter and leave foreign ports.

BoatUS also advises boaters who may have received mail that they believe is misleading or deceptive to contact the U.S. Postal Inspection Service at 877-876-2455 or through its website <u>https://postalinspectors.uspis.gov</u>.

Member agrees that he/she will indemnify and hold harmless the Released Parties from any and all liability, actions, causes of actions, debts, claims and demands of every kind and nature whatsoever, which the Member now has or which he/she may have arising out of or in connection with his/her participation in any PSC events.

Member fully understands that the boat and equipment made available during PSC events come without any warranties, guaranties or other representations whatsoever by PSC or any of the Released Parties. Specifically, Member fully understands that the boat and equipment made available during PSC events DO NOT COME WITH ANY WARRANTIES OF MERCHANTABILITY AND/ OR FITNESS FOR A PARTICULAR PURPOSE from PSC or any of the Released Parties. Member agrees that he/she shall not rely on the judgment of any of the Released Parties when participating in PSC events.

Member assumes all of the risk of participation in PSC events with the full understanding that sailing can be a hazardous sport, including, but not limited to the risk that one or more of the Released Parties may cause property damage, personal injury (either physical or emotional) or death by their carelessness, negligence, gross negligence and/or strict liability.

Member assumes the responsibility to judge his/her fitness to participate in PSC events and his/her capabilities to face the risks and hazards inherent in any of the activities related to these events. A separate form is required for each trip. **Make check payable to**: Philadelphia Sailing Club & send to the Charter Reservationist responsible for the trip. **Only members who have completed the required two weekend trips, on club chartered boats, may sign up for PSC sponsored trips of one week or more**. Day sails do not qualify as a weekend trip, even if two are taken. **Payment in full is due at signup for Chesapeake Bay trips, unless otherwise specified. Please write trip date on check.**

Cancellations for weekend trips are subject to a \$40.00 cancellation fee. Fee for canceling from a 5 day or longer Sail Program trip is \$75. Cancellations before the cancellation period (60 days prior to trip departure) will be refunded minus the fee. Refunds after the cancellation period will be made only if a replacement is found.

Trips will not be canceled nor refunds made for any reason unless cancellation and refund is made by vendor.
